# Financial Conflict of Interest: Instructions for Researchers

**Updated: 02/01/2025** 

The PI and/or Coordinator should ask all Co-Investigators to complete a Financial Conflict of Interest (FCOI) disclosure form in IRBNet/VAIRRS. It is crucial that each investigator has the study "shared" with them in IRBNet (i.e., they must be listed as study staff), and each investigator must be provided the study information shown below in red font.

# Instructions to Investigators: Completing a FCOI Disclosure

- All investigators (PI and Co-Is) must complete a Financial Conflict of Interest (FCOI) disclosure form at initial submission of a new project and annually thereafter. The disclosure form is called "OGE 450 Alt". Annual submission is required whether or not a FCOI actually exists, and whether or not a FCOI has previously been cleared by the Office of General Counsel (OGC). This is because the nature of FCOIs may evolve over time or there may be changes in applicable laws.

- Once logged into your account, click on "My COI" and then "Create an Initial, Interim, or Annual Disclosure" as shown in the screenshot below.

The "My COI" page lists each of the disclosure forms that you have created so far. To create a new OGE 450 form, simply click "Create an Initial, Interim, or Annual Disclosure."



• The following guidance explains how to fill in some of the fields:

**Select a Project**: It is important to choose the correct project from the drop down list. The PI or Coordinator will tell you which project to choose. If you do not see the correct project listed, then you may not have been added as study staff by the PI or Coordinator. Please contact the PI or Coordinator and request that they "Share" the project with you in IRBNet. **Duty Station**: North Florida/South Georgia Veterans Health System

Telephone: your business phone number

VA Email: VA or UF email address is acceptable

**Sponsor of Study**: PI or coordinator is responsible for informing the Co-Investigator of what to use for "Sponsor". The last page of this document shows the possible options (highlighted in yellow).

**Funding Source**: PI or coordinator is responsible for informing the Co-Investigator of what to use for "Funding Source". The funding code for the study is available on the **Research "Study Tracker" Database** (the link for this database is on the <u>Research Service webpage</u>). Find your study in the database and look for the section called "ePROMISE Funding Information". You should compare this information to the options shown in **green** on the last page of this document, to make sure that the database is still correct. If you think there may be an error, contact the Research Office.

**Cooperative Studies Program Study?**: "CSP Study" refers to a VA funding mechanism for multi-site research. If you are part of a CSP Study you are likely aware of it. Otherwise the answer is "No".

- The website will walk you through a series of questions for the COI disclosure.
- The sections on "Income and Compensation" and "Business Relationships" ask about relationships with "an entity (including the university affiliate) whose financial interests could be affected by this study". The financial interests mentioned here do NOT apply to salary from dual-appointments. Rather, the financial interests must have a close causal link with the research that is being conducted. If there is no such link, answer "No" to these questions.
- After you have completed the COI form you will see the status as "not submitted". That's OK, the Principal Investigator or Research Coordinator will complete the submission.


# Instructions to the Principal Investigator and/or Research Coordinator responsible for submitting the package in IRBNet

- Please re-read the first paragraph of this document ("The PI and/or Coordinator should ask all Co-Investigators...").
- From the "Project Overview" page, <u>create a new package</u>. FCOIs must be submitted in a package that is <u>separate</u> from the package used to submit study documents (e.g., protocol, consent forms, etc.). This is because each package will be submitted to a different review board. The FCOI package will be submitted to the "NF/SGVHS Conflict of Interest Board". The study document package will be submitted to the "NF/SGVHS Research Administration Members Board".
- •You can only have one new unsubmitted package open at a time within your IRBNet project. If you already have a package open for your study documents, you will need to wait until it is submitted before you can create your FCOI package (or vice versa). If this is preventing progress (e.g., a Co-I is not responding to your requests to complete the FCOI disclosure), then a workaround is to submit your incomplete package, then inform the IRBNet administrator that you are not actually done and ask for your package to be unlocked. This works because once a package has been submitted (even if unlocked again), it clears the way for a new package to be created.
- •The following instructions explain how to link FCOI disclosures to the package:

In IRBNet, research projects are organized into "packages" of documents that can be submitted for review. To get the OGE 450 forms for you or your team ready for submission, first link the completed forms to a package using the Designer (you must have Full or Write access to the project):

- 1. Select your project from the My Projects page.
- Make sure all research team members have been provided access to the project on IRBNet (otherwise you won't be able to link their OGE 450 forms).
- 3. Click the Designer button on the left menu.
- 4. Click "Link / Un-Link COI Disclosures".



- 5. You will be presented with a list of disclosures for every study team member with access to the project. Select the OGE 450 forms that you want to submit, and click Save.
- Before submitting the package, ensure that ALL co-investigators have completed their FCOI disclosures and that all are linked to the package. To submit, follow the instructions below and make sure to choose "NF/SGVHS Conflict of Interest Board".

After all required disclosure forms are linked to the package, click the "Submit this Package" button, and select your facility's COI workspace. Packages containing disclosure forms should **only** be submitted to the COI workspace. It is the responsibility of the project owner (someone with "Full" access) to submit the package. Always follow local COI SOPs.



After you submit the package, you will be able to view the status of the FCOI review from the "Project Overview" page in IRBNet. The list of study staff on this page has a column for "COI" where you can view the status by observing the colored triangle next to each person's name.

- If there is a gray triangle with a question mark, no COI disclosure was submitted. A gray triangle is OK for staff who are <u>not</u> project investigators.
  - o If there is a yellow triangle with a question mark, the COI disclosure was submitted but is still under review.
  - If there is a green triangle with a checkmark, the COI disclosure was reviewed and approved.

Use the green highlighted text for "Funding Source"
